## INTRODUCTION

The Northern Tasmanian Home for Boys opened on 10 December 1921 at 'Glenara', Franklin Village, on the Hobart Road near Launceston. A committee of prominent Launceston citizens purchased the property with the intention of establishing a home, as opposed to an institution or training school. Located on 13 acres, the substantial eight-roomed brick house had a separate billiard room with sleeping accommodation for 30 boys above. The non-sectarian Home, conducted by a Board of Management, opened with 14 boys.

The first superintendent and matron, Frank and Anne Parkin, were replaced in 1927 by Major and Mrs L G H Bradgate, followed by Ivan and Daphne Filluel who were appointed in December 1928. The Filluel's term in office was most successful, spanning 31 years: to the boys they were known as 'Dad' and 'Mum'. There were 25 boys at the Home when they commenced duty and 51 boys at the time of their retirement in 1959. The Filluels were succeeded by their son and daughter-in-law, Mr and Mrs V Filluel, who had been assistant superintendent and matron for some years. They resigned in 1967 and were succeeded by Mr and Mrs R G Willis who served until 1979. Mr Milton Blanch was the last superintendent, from 1979 until he resigned in March 1982.

Prior to 1946 nearly all the boys were wards of the State, but after that date boys were also admitted by private arrangement. Problem children were not accepted. Care was taken to avoid an institutional atmosphere and to provide as far as possible a normal home life. The boys were encouraged to play football and cricket and participate in other sporting activities. They enjoyed an annual summer holiday camp at Meercroft, near the Bluff at Devonport.

For some years the work performed by the boys at the Home after school hours prepared them for a rural life and many boys were found employment on farms. Products from the Home's small farm included milk, cream, eggs and vegetables and at one stage meat requirements were largely met from sheep and cattle raised on the property. Sheep, cattle and cream were also sold. One hundred acres purchased from the neighbouring Glen Hay property was added to the Home's land in 1964.

All the boys attended Youngtown State School until 1956 when two boys attended Launceston High School. In 1960, 10 boys commenced at the new Kings Meadows High School. From 1967 tutors assisted boys with their home studies. Every endeavour was made to help boys with their chosen employment.

In 1964 a swimming pool was added to the Home's amenities and a property was purchased at 56 Racecourse Crescent in Launceston as a hostel to cater for boys who entered into apprenticeship or other employment in the city after leaving the Home. The hostel was sold in 1969.

Mr Willis introduced a holiday parent scheme which enabled the children to live in a normal family situation during school holidays instead of going to Meercroft at Devonport: this successful arrangement continued until the Home closed.

The Home was largely self supporting, receiving generous financial and in kind assistance from a wide cross section of the community. Products from the Home's farm made a major contribution to running costs. The Glenara Ladies Auxiliary, formed in 1970, provided welcome financial assistance, particularly through the 'Gown of the Year' function, successfully conducted for some years. Government grants helped fund building programs. Finance also came from Government payments for wards of the State and a subsidy for children admitted under a private arrangement, child endowment and bequests.

In 1971 the Home's name was changed to Glenara Northern Tasmanian Home for Boys and in May 1973 it became Glenara Childrens Homes.

By the 1970s there was a change in the concept of institutional homes and orphanages in favour of placing children in family environments. In line with social welfare thinking, in 1974 the Board built two cottages where children were accommodated in a less institutional environment, enabling family units to be kept together under the care of cottage parents. Funds came from a public appeal and Government assistance. The first girl was admitted in July 1974, when she was re-united with her brothers.

In March 1978 fire damaged the double-storey dormitory, causing an escalation of a planned rebuilding program. Generous support for a Mayor's Appeal saw the official opening of Stage 1 of this program, a dormitory for boys displaced by the fire, open in September of that year.

There were 50 children at the Home in March 1978, but by 22 February 1982 the number had declined to 19. The decrease in income due to the reduced number of wards of the State maintained by the Government, coupled with demands for increased wages caused financial difficulties, leading to the Home's closure. By June 1982 there were no children in care at Glenara.

The following year the Board of Glenara entered into an agreement with the Commonwealth Department of Employment and Industrial Relations to establish a Work Preparation Programme aimed at helping young people enter the workforce with practical experience. Initially farming, horticulture and kayak building were taught. In 1984 the name was changed from Glenara Childrens Homes to Glenara and later it operated as Glenara Training Services. The property was sold to Southern Cross Care (Tasmania) in 2000.

The collection was donated to the Queen Victoria Museum and Art Gallery in January 2002.
