INTRODUCTION

The Royal Society of St George was founded in England by Howard Ruff in 1894, although its origins may be claimed to date from a St George's Society established in America as early as 1770.

The Society is a non-sectarian and non-political body and has Her Majesty Queen Elizabeth II as Patron. Its badge was that of St George and the Dragon (based on a medieval legend), and its objectives are:

to foster a love of England and the Commonwealth through the dissemination of the knowledge of English history, traditions and ideals, to maintain the memory of those from all walks of life who have served England or the Commonwealth, to ensure that St George's Day is duly celebrated, to provide opportunities for English men and women throughout the world to meet together

The Society's affairs are vested in a Council. Branches could be established in any part of the world, subject to Council sanction and the payment of capitation fees to the London Head Office.

The first branch of the Royal Society of St George in Australia was established at Scottsdale in Tasmania's north east by R T Dyer on 23 April 1900 with 13 members. The first minute book of that branch is included in this collection (2/4). It came from the estate of A W Biggs (a former president), and was passed to the Launceston Branch by the late Rev W H MacFarlane.

A Launceston branch, also established early this century, had ceased to exist by 1919. However, the branch was re-convened by Sir Gordon Rolph at a meeting at the Town Hall on 9 July 1945. By 1959, it had 150 members, although membership subsequently fluctuated, with 70 members in 1969, 130 in 1985 and 93 in 1994. In the 1960s, interest was expressed in seeking members from sponsored British migrants to the state.

Branch membership included a president (elected annually), vice-presidents, life members, ordinary members and honorary members. Over the years, activities included annual celebration of St George's Day and Trafalgar Day, an annual church service at St George's Church, Invermay, presentations to St George's School, Newstead, and other schools, establishment of a School Essay Competition, the award of an Art of Speech prize at the Launceston Competitions, and donations to various charitable organisations including St Giles Home, 'Tresca' (Fairbridge Society Home for Children, Exeter), the Multiple Sclerosis Society of Tasmania, Salvation Army, Launceston City Mission, Masonic Garden Village Special Care Unit, Launceston War Memorial Community Centre Association, Tasmanian Deaf Society and *The Examiner*'s Winter Blanket Appeal.

At the annual general meeting of the Launceston Branch held on 4 April 1995, there were no nominations for either president or secretary. Amidst other concerns about its aging membership, many of whom were also members of the Royal Commonwealth Society, and difficulty in attracting younger people, it was decided at a special council meeting on 5 September 1995 to disband the Branch, effective from 30 November 1995. All liabilities were discharged and grants of \$2,500 made to the Launceston Church Grammar School and Scotch Oakburn College, for prizes in English. Remaining members, residual funds and some memorabilia were transferred to the Northern Tasmanian Branch of the Royal Commonwealth Society.

The collection was donated to the Queen Victoria Museum in July and October 1996.
