INTRODUCTION

Waverley Woollen Mills, Australia's oldest weaving mill and last blanket weaving mill, was established by Peter Bulman in 1874. Bulman, who migrated from Scotland in 1858, had farmed at Myrtle Bank, Breadalbane and Patersonia before venturing into the woollen industry.

Deciding to take up the challenge of the Tasmanian Government's 1869 offer of a bonus of £1000 for the first £1000 worth of all-Tasmanian manufactured woollen goods, Bulman leased a suitable site from James Scott at Distillery Creek, some three miles from Launceston. In 1872 he travelled to Scotland where he entered into partnership with Daniel, Archibald and David Johnstone, owners of a mill at Selkirk. The necessary equipment was obtained, the Johnstones proceeded to Tasmania and Bulman, Johnstone & Co. commenced woollen production on 13 May 1874.

Three months later the company's products sold at auction in Launceston for £1143; the Government bonus was awarded in February the following year. After the partnership was dissolved in 1883, Bulman was joined by his brother-in-law, Robert Hogarth. Hogarth had worked at the mill prior to spending 1878 to 1881 in Scotland learning the wool trade.

Power for the mill was originally obtained from a 25 foot water wheel using water piped from a dam on Distillery Creek. Later turbines replaced the water wheel and iron piping replaced the wooden chutes. In 1889 Bulman installed a hydro-electric scheme to run some of the machinery and to light his residence.

By 1888 tweeds and blankets, the company's principal products, and serges, shawls and flannel were marketed in Tasmania and the Australian colonies, the blankets having a particularly good reputation. In the 1880s the warm and water repellent "bluey" cloth, popular with outdoor workers, was produced. In 1884 a wholesale clothing factory making ready to wear garments was established in York Street, the factory continuing until the 1920s.

Upon Bulman's death in 1896, Hogarth became the sole proprietor. At the turn of the century the mill was employing about 100 people. Hogarth converted the business into a company in 1916, when he took his sons J Russell and R Harold into partnership. The mill continued to be run by the Hogarth family until 1981.

During the Second World War over one million blankets were made for British and Allied forces. The mill concentrated on blankets until 1962 when electric blankets and tufted carpet were also produced.

The 1970s were difficult years for the textile industry and the mill was on the brink of closure when it was purchased by John and Peter Temple of the Mohair Farm at Bendigo in 1981.

The Temples revitalised the mill by combining tourism with wool production. Tours were conducted through the factory and a showroom on the premises sold quality products made from pure wool and wool and mohair blend, including garments made in its tailoring department.

John Fahey of Melbourne bought the mill from receiver/managers in 1990.

The collection was donated to the Queen Victoria Museum and Art Gallery in March 1997.
