INTRODUCTION

The Northern Club was established 12 years after the Launceston Club as 'a club where business men could meet in congenial surroundings to relax, read the daily newspapers, ... have a quiet drink or meal ... [and] ... where important business contacts could be met in comfort and privacy'. Rejecting the title 'Commercial Club', the Northern Club fulfilled its purpose for 100 years.

The first meeting on 12 March 1894, at the former International Hotel in Brisbane Street, Launceston, was attended by 16 gentlemen. The first President was H Ritchie. In its first year the Club attracted 100 members. Membership had more than doubled by the early 1950s, reached 275 by the mid 1960s, but fell to 170 by September 1996. Members have represented various professions, politics, industry, commerce and sport, and included accountants, solicitors, graziers, stockbrokers, engineers, bank managers, clergymen, merchants, insurance agents, company managers and directors. Town members predominated, with a smaller number being country members. New members (elected by ballot) required 25 supporting votes from existing members. Honorary membership was occasionally extended by invitation to other persons (eg State Governors, Mayor of Launceston). The first life member was elected in 1932. In more recent years, membership was also opened to women, although none took it up. The Club's general business was managed by a committee (elected at the annual general meeting), three of whom also constituted the house committee. Special committees (eg that appointed to plan the Club's centenary) were appointed from time to time.

Clubs affiliated with the Northern Club included the NSW Sports Club (Sydney), Melbourne Savage Club, Stock Exchange Club (Melbourne), Tattersall's Club (Adelaide), Athanaeum Club and Civic Club (Hobart), and several North West Coast clubs. Many interstate and overseas visitors were also welcomed to the Club over the years. Inter-club competitions, particularly with the rival Launceston Club, became popular in the 1920s, and included cricket, bowls and golf.

The Northern Club celebrated its jubilee in 1944, and its centenary in March 1995. However, in a climate of changing social and business patterns, higher costs, and declining membership and revenue, the Club announced its closure in September 1996. The records included in this collection were passed to the Queen Victoria Museum and Art Gallery at that time. Other assets were to be sold, including the Club's premises at 61 Cameron Street. This property had initially been leased by the Club in 1898, and was purchased from the National Bank of Tasmania in October 1902. It has been extended and renovated at different times. Verandahs were added in 1905, the present street face and major internal renovations were completed in 1937 and 1969 respectively, and the dining room was redecorated in 1992.

The collection was donated to the Queen Victoria Museum and Art Gallery in 1997, with additional items donated in 2004.
