INTRODUCTION

The Caring Families Association Inc. was formed at a Christmas party held at Mr Laurie Kelly's home at Westbury in 1978. Composed of families of people who suffered from life threatening diseases, such as leukemia, its aim was to give emotional and financial support to those families and to raise money for research and for equipment used in treatment of those diseases. Association meetings were held at various northern Tasmania locations, with information about the Association available from the Children's Ward at the Launceston General Hospital.

At the time the Association was formed, there were virtually no financial or emotional support mechanisms available for children suffering from leukemia or any life threatening disease, nor for their families.

By 1999 numerous groups and organisations existed which offered a wide range of assistance. That year, because the Association's membership was not expanding and it had become difficult to attract new people, the Association amalgamated with "Bluey Day", an organisation with similar objectives. The new name was to be Bluey Day Caring Families Inc. However this move did not prove successful and the Association was dissolved on 9 March 2000.

During the 22 years of its existence the Association raised and donated hundreds of thousands of dollars for equipment and furnishings for facilities that cared for sufferers of leukemia and other life threatening diseases.

The collection was donated to the Queen Victoria Museum and Art Gallery in July 2001.
