INTRODUCTION

The Independent Order of Rechabites (I.O.R.), commenced in Salford, Manchester, in 1835, was established in Tasmania in 1843. The name of the Order had Biblical connotations, being taken from the Rechabites, who were commanded 'not to drink wine' and directed to 'live in tents'. The Order was composed of districts and the branches called 'tents'.

The objects of the society were to spread the principles of total abstinence and to raise funds for sick pay, funeral allowances and medical attention for members.

The Society commenced in Launceston in 1843 when the Star of Tasmania Tent was formed. Early meetings were held in the Wycliffe Hall in Vincent Street, Launceston. Later tent meetings changed their venue to the York Street Temperance Hall, owned by the Tasmanian Teetotal Society. In 1894 a 99 years lease of the property at a peppercorn rental was secured and a lodge room and office were erected together with a new front to the building. Following an act of parliament in 1903, the property was vested in the trustees of the Tasmanian District of the I.O.R.. (1) The Rechabite Chambers were demolished in 1957 (2) and a new building, with shops, offices, a lodge room and car parking in the basement, constructed by the Society on the site of its previous building at 109 York Street, was first occupied in April 1958.

In 1955 the Independent Order of Rechabites, Olive Branch Tent took over the Star of Tasmania Tent. The number of members had declined due to the Commonwealth Government's introduction of health benefit schemes after the Second World War.

The Australian Government Actuary, in an investigation in 1974, reported that membership of the Society was declining rapidly. The return from the 109 York Street property was unsatisfactory and the Actuary recommended its disposal.

The Independent Order of Rechabites, Star of Tasmania & Olive Branch Tent, became financially unviable and was wound up on 30 June 1981.

The collection was donated to the Queen Victoria Museum and Art Gallery in December 2002, with additional items donated in March 2003.
