## INTRODUCTION

St Mary's cheese factory was built about 1938-1940 by Murdoch Bros, Hobart. It was sold to St Mary's Co-operative Dairy Society Ltd in 1948. The Co-operative had met for the first time on 2 June that year. Always a small concern, it remained independent of the larger North-Eastern Co-operative Dairy Company (which became part of United Milk Tasmania Ltd in 1981) throughout its existence.

The St Mary's Co-operative manufactured cheese between 1948 and 1969 and contributed exhibits to the dairy produce section of the *Made in Tasmania* exhibition in 1967. The Co-operative's whole output was sold directly, although it apparently used Messrs Dawborns as selling agent initially. Early buyers included Murdoch Bros, Pearce & Pearce, Burgess Bros, F W Heritage (Hobart), O'Brien's (Campbell Town), Hobbs & Pilcher (Bothwell), C H Smith (Launceston), R P Furnage (Deloraine). Although cheese production had ceased by November 1969, the Co-operative continued trading for some time through its agencies. At different times, these agencies included Lawrence & Hansen Pty Ltd, Alfa Laval Separator Coy Ltd, Savigny & Smith (Launceston), Glazebrook Paints, and Goliath Portland Cement. By 1964 the Co-operative's profit was largely due to its various agencies and it was having difficulty sustaining its supply of cheese. The main reason cited for the closure of the St Mary's cheese factory a few years later was declining support by local dairymen and consequent reduced milk supply, but its production appears to have also been adversely affected by seasonal conditions throughout the 1960s, increased costs and local competition, changing market conditions, and complaints about factory wastes in the local water supply. The property was subsequently sold to J and J R Wines.

The collection was donated to the Queen Victoria Museum and Art Gallery in 1994 during a major research project conducted by the Museum into the history of the dairy industry in Northern Tasmania by Jill Cassidy (see Other Sources) and September 1996.
