INTRODUCTION

The Launceston Gas Company was formed in 1858 following a public meeting at the Cornwall Hotel 'for the purpose of Lighting with Gas the Town of Launceston'. Despite it being a private company, it was run as a public utility. In October 1858 the site of the works, bounded by the Eastern Esplanade, Cimitiere, Willis and Wescombe streets, was purchased. William Falconer, of Glasgow, Scotland, was appointed superintending engineer. Gas was produced from imported coal and on 5 April 1860 Launceston's 123 street lamps were first lit with gas. Four days later the newly completed Mechanics' Institute was the first building to be lit by gas. The company paid its first dividend in 1862.

A stove designed for and manufactured by the Company was on view in the Tasmanian Court at the Melbourne Centennial Exhibition in 1888-1889. In a pamphlet printed for the Exhibition, the Company stated that it was the first gas company in the Australian colonies to introduce the system of hiring out gas stoves and fittings. Consumption increased steadily until 1896 when electric light superseded gas for street lighting. On 12 February 1896 the first electric lights were installed in the city and three days later gas street lights were lit for the last time. This was a blow to the Company, however at the turn of the century 3,500 households and businesses consumed gas, with 36 miles of mains and 43 miles of service pipes laid down. Fifty hands were employed in the Company's workshops manufacturing cooking and heating stoves and water heaters.¹

The disastrous 1929 flood completely engulfed the works, but services were restored in record time. In 1932 the carbonising plant was superseded by the installation of continuous vertical retorts, the plant being the first of the battery type to be put to work in the Commonwealth.

In 1940 the Company opened offices, showrooms and a demonstration room where cookery demonstrations and classes were held, at 90 St John Street. This resulted in a large increase in sales of appliances. The St John Street property was sold in 1982.

During the difficult days of the Second World War, when coal ran out, the company used oil, which was much more expensive.

In 1959 a carburetted water gas plant using Tasmanian coal was installed, consumers then numbering more than 6000.

In the first 100 years, the Company had only four secretaries: 1859-1872, John Grant Smith; succeeded by Arthur Green to 1917, then H R Lakin to 1930, followed by A G Woolston. The Hart family was connected with the company from its inception for many years.

To counteract State Government policy of installing electrical appliances in government housing projects, the Company ventured into land subdivision, buying blocks and selling these on favourable terms to gas users. In 1965 the Company bought 30 blocks in a subdivision at Young Town with the proviso that gas must be used in the houses. Selected builders were helped with finance to build gas-equipped homes. In 1967 the Company bought a large area of land off Reatta Road in Trevallyn, with blocks to be sold at cost. The subdivision, named "New World", with attractive terms for purchasers, was developed in two stages, 31 blocks being sold in the first stage and 40 blocks in the second stage.

In 1970 the Company introduced a bulk liquefied petroleum gas tanker to serve commercial and industrial requirements for LP gas. The company had commenced selling LP gas in cylinders to all districts in northern Tasmania in 1958.

The gas manufacturing plant became obsolete and in a major redevelopment of the plant in 1978 gas was produced using butane feedstock from Bass Strait natural gas fields. Unlike the old plant, butane did not produce the residuals, coke and tar.

In the late 1970s the Company experienced difficult trading periods due to the Federal Government's export parity pricing policy which increased enormously the price paid by the Company for butane gas. The Company undertook a reorganisation and rationalisation program and actively sought areas of diversification to complement the existing operation, including an investment program for oil and gas exploration in the Bass Strait region.² The first autogas outlet in the Launceston city centre to service vehicles converted to LPG was opened in 1980.

The headquarters were moved from St John Street to the renovated old office building on the gasworks property on the Esplanade in 1981.

In 1984 the Company's name was changed to the Gas Corporation of Tasmania Limited.

Manufacture ceased in 1988 when the company was sold to Boral, who imported all gas requirements from the mainland. Town gas was finally turned off on 12 December 1996 and customers were converted to use liquid petroleum gas.³

In 2000 Boral's energy business changed its name to Origin Energy.⁴ Origin relocated its operations to a new centre in Murphy Street in November 2007 and in the same year redevelopment of the historic gasworks site began.⁵ (Apart from the footnotes, the above information comes from the records.)

The collection was donated to the Queen Victoria Museum and Art Gallery in July 1997.
