#### INTRODUCTION

The Commercial Travellers Association of Tasmania was founded by a large number of commercial travellers at a meeting held in the Launceston Hotel on 14 April 1900. The *Examiner* of 17 April 1900, in its report of the meeting, stated that the aim of the association was to watch 'the interests of commercial travellers, and the strengthening of their hands in necessary reforms'.

Tasmania was the last of the Australian colonies to establish a commercial travellers' association. (1) Affiliated with the United Commercial Travellers' Association of Australasia (UCTAA) which had been formed in 1895, the Tasmanian association sent delegates to the annual conferences of the federal body, with some Tasmanian presidents becoming presidents of the UCTAA.

Meetings were held at the Launceston Hotel until August 1902 when the club moved to premises at 47 Cameron Street, near the corner of George Street on the south west side. (2)

The association was active in its endeavours to improve the working conditions of its members. A major concern was hotel accommodation. Hotels were inspected, appointed and issued with certificates, and unsatisfactory sanitation reported to the relevant authorities. The hotel list was revised annually, with some hotels being struck off. Rail travel was also important: letters were sent to and a deputation waited on the general manager of the railways concerned with matters such as timetables, faster services, lavatory provision on trains and at stations, cloak room charges and freight rates for samples.

The club provided for the social life of its members with amenities at the club, including billiard tables, newspapers and periodicals, 'At Homes', smoke concerts and an annual picnic.

In July 1907 Dr L S Holmes' two-storey residence at 78 Charles Street was purchased. Soon after the move from Cameron Street to Charles Street, a photograph of the CTA Club building appeared in the *Weekly Courier* of 24 August 1907.

The club had extended its operations to Hobart in 1906 and a club house opened there in July 1907.

In June 1909 the committee recommended that the property known as the Fire Bell Tower at 160 Brisbane Street be purchased from Goodwin's estate. Alterations were made to the Brisbane Street premises which were to be the club quarters whilst a new building was constructed in Charles Street.

Messrs J & T Gunn's tender at 4196 pounds was accepted for the new building in Charles Street in June 1910. The existing building was demolished. (3) The Governor of Tasmania, Sir Harry Barron, laid the foundation stone on 9 December 1910 and CTA President Duncan laid the topmost stone of the building on 7 November 1911. The CTA Club was opened on 4 April 1912 and the *Weekly Courier* published a photograph of the completed Charles Street building that day, calling it a handsome structure. The annual conference of the UCTAA opened in the new club premises the following day. (4)

From its early days the CTA was a community minded organisation. It donated cots to the Launceston General Hospital and toys at Christmas time. In October 1914 the association organised a patriotic carnival at the Elphin Show Grounds in aid of funds for the European War (5) and in 1921, to assist in the movement to establish a Northern Tasmania home for boys, a second gigantic carnival was held, again at the show grounds. A lengthy description and photograph of the event appeared in the *Australasian Traveller* of 6 January 1921. During the Second World War the club dispatched in excess of 1500 food parcels to Britain and a fellowship fund was established to assist members who fell upon hard times on their return from the war. (6)

The Memorandum of association rules and by-laws of the Commercial Travellers' Association of Tasmania (Launceston, 1924?) included details of the mortuary benefit fund, which was paid to a member's widow, relief fund for aged, necessitous or incapacitated members and scholarship fund for members' children, along with rules for accommodation etc.

The royal visit of the Duke of Gloucester to Launceston on 16 November 1934 was a notable occasion for the CTA. During the royal progress through the city, a halt was made at the CTA Club where representatives of the CTA of Tasmania presented an address of welcome to His Royal Highness.

NG Harper's *Tasmanian passes*, *checks & club tokens*, in the chapter on the Commercial Travellers Club, provides a good description of the poker machines used in the club. As early as February 1904 committee minutes mentioned that the secretary was instructed to procure a supply of metal tokens for poker machines, and it was resolved that three poker machines be ordered from America. Poker machines were withdrawn in 1938.

A major building programme was undertaken in the late 1950s/early 1960s when some fourteen motel units were erected. (7)

With the introduction of television and increasing number of licenses issued to sporting clubs, introduction of the .05 drinking law and the fact that poker machines were not given to clubs, membership of the CTA started to decline, causing the club to sell its 78 Charles Street premises and associated buildings at 160-162 Brisbane Street (comprising a 15 unit motel, two lock-up shops and commercial rooms above) in 1972. (8) The club's final day of trading at Charles Street was 31 August 1975. (9) In September 1975 the complex was demolished to make way for a Venture Store. (10) In 2006 the building is occupied by Target Australia Pty Ltd.

The CTA Club moved to 127 Wellington Street, part of the former Mitchell Motors building, near the Canning Street corner, in 1976; in the interim it met at the Centennial Hotel. (11) The Charles Street foundation stone was removed to the Wellington Street building, along with the club's magnificent blackwood and mirror bar, which had to be reduced from seven bays to five to fit on the ground floor of the new club. When times became difficult, the bar was moved to an upstairs room on the same site and reduced to four bays.

The Club closed in 1988, and the bar, which had to be reduced to three bays, was leased to the RSLA Club at Anzac House in Paterson Street. With Anzac House about to be demolished, the bar was given on permanent loan to the Masonic Club at 34 George Street. (12) After the Masonic

Club closed, Fidlers Brasserie opened in the premises in November 2000 and the bar was a feature of the establishment. (13)

The collection was donated to the Queen Victoria Museum and Art Gallery in August 2000 with additional items in October 2002 and June 2003. This additional material is listed as 5/11-5/32, 6.Legal Records and 7.Additional Minutes of Meetings.
