#### **INTRODUCTION**

Tasmanian Flour Mills Pty Ltd has its origins in successful flour milling businesses conducted in northern Tasmania in the 19th century by T W Monds and Thomas Affleck.

Thomas Wilkes Monds commenced his milling business at the Albion Mills on the North Esk in 1865 and at Carrick in 1867. In 1908 T W Monds & Sons commenced milling operations on the corner of Lower George Street (later Shields Street) and the Esplanade, Launceston. At 2002 the buildings, much extended and modified, formed the headquarters of Tasmanian Flour Mills Pty Ltd.

Thomas Affleck bought a flour mill at Newry, near Longford in 1871. After the mill was destroyed by fire in 1897, he built a mill at Longford in 1898. His Crown Mill in Cameron Street, Launceston was completed in 1897. This mill remained a part of Monds & Affleck's operations until 1977.

Monds & Affleck Pty Ltd was formed when T W Monds & Sons and T Affleck & Son Ltd amalgamated in 1918. Most of the collection relates to Monds & Affleck, which continued to trade under that name until HMA Ltd was taken over by Pivot Nutrition Pty Ltd in 1995.

In 1960 Monds & Affleck Pty Ltd merged with Holyman Holdings Ltd to become Holyman Monds Affleck Ltd. Holyman Holdings Ltd had diverse interests including shipping, engineering, automotive, tyre manufacture and timber milling. Subsidiary companies included motor distributors and electrical and engineering supplies. Captain William Holyman had established a shipping company after his arrival in Tasmania in 1854. His family continued to be successful in the transport industry and by the time of the merger his descendants were involved in a number of companies trading under the Holyman name.

The company name was abbreviated to HMA Ltd in 1987. The company's core interest was flour milling at Launceston and Longford, with holdings in Gibson's Ltd, Hobart, Cripps Bakery, Hobart and North Western Flour Mills Ltd at Devonport. However the collection reveals a complex picture of widely diversified holdings, subsidiary companies, with companies bought, sold, dissolved and of name changes.

In 1995 HMA Ltd was taken over by Pivot Nutrition Pty Ltd, which in turn was taken over by Tasmanian Flour Mills Pty Ltd in 2001.

The collection was donated to the Queen Victoria Museum and Art Gallery in May 2002. The records are arranged in alphabetical order by company.
