INTRODUCTION

Ritchies Mill Arts Centre was established in 1977 in response to the need to provide a base for amateur arts and crafts groups and community arts activities in Launceston. The historic mill buildings, purchased by the government in 1974 and controlled by the National Parks and Wildlife Service, were leased to the Centre for a peppercorn rental.

When the buildings were handed over to an interim management committee in mid-1976 they were in an unsafe condition and badly vandalised. Government funding allowed major improvements and the Centre was officially opened on 24 September 1977, with a full-time director appointed in late 1977. In 1983 when funding for the Centre ceased, this position was terminated and Ritchies Mill Arts Centre Ltd, a nonprofit organisation, was run by a voluntary board of management. Board members were elected by subscribing members at the annual general meeting.

The basic purpose of the Centre was to provide a working environment for artists and craftsmen of all disciplines. Resident arts and crafts groups and individuals who rented spaces represented a wide range of activities, including manual crafts and visual and performing arts. Rents paid by the tenants helped the Centre to be financially viable.

One of the earliest community activities was the children's vacation program which ran for some years until 1989. A program of exhibitions was instituted, workshops held and a tea room and craft shop opened in the restored Miller's Cottage in 1981. Other Board initiatives included the Launceston Arts Festival in 1983 and artist-inthe-community projects, which included the painting of murals.

Longstanding tenants were the Tasmanian Potters Society (North), an original tenant, Ripples Café (later Restaurant) in 1984 and Gallery Two in 1987. Gambit Theatre and the Launceston Art Society were among the early tenants. Arthouse was located at the Centre from 1990 to 1994.

In 1987 when the Board renewed its lease for another ten years, in order to become more viable, the fundamental aims of the Centre changed to the promotion of quality Tasmanian artwork at a professional level and the development of an arts based industry. The Mill's location on the banks of the Tamar River, opposite the Penny Royal tourist complex and in close proximity to the Cataract Gorge made it an ideal site to pursue these aims. An artist-in-residence project and an emerging artist scholarship and program were instituted.

In 1994 the Board approved a proposal from the two main tenants, Ripples and Gallery Two, to take over the head lease and that the balance of the Board's lease be cancelled.

Ritchies Mill Arts Centre Board handed back the lease of the building to the State Government in 1995 and Ritchies Mill Art Centre Ltd was deregistered in 1998.

Some items relating to Gallery Two are included in the Ritchies Mill Arts Centre collection. This successful commercial gallery continued at the Mill after the Board ceased to exist.

The collection was donated to the Queen Victoria Museum and Art Gallery in February 2000.
