## INTRODUCTION

George William Burrows was born on 10 November 1878 at Crosby, Prospect, near Launceston, son of Henry Burrows, a horse dealer, and his wife Elizabeth (nee Heath) Burrows.<sup>1</sup> At an early age he started to earn his own living and in 1906 he purchased 200 acres at North Scottsdale.<sup>2</sup> He named the property “Blackwood Park” and in November 1913 he entered into an agreement with builders to erect a farmhouse on the property.<sup>3</sup> “Blackwood Park” eventually became one of the show places in the district.

George was a horse dealer and noted throughout Tasmania as a breeder of draught horses. He travelled twice to England to buy horses, made six trips to New Zealand and attended the Royal Sydney Show for 35 years exhibiting his Clydesdale stallions. He went to Melbourne regularly to trade horses and attended Bridgewater horse sales.<sup>4</sup>

George married Amelia Elizabeth George, born on 26 July 1885, daughter of Elijah and Emma George<sup>5</sup> on 18 November 1908 at St John’s Church, Launceston. Amelia’s parents ran the Red Feather Inn at Hadspen. George and Amelia raised a family of two children, Millicent and Trevor. Amelia died on 27 April 1935. George later married Gladys Lyon and they had a son, George.<sup>6</sup>

George revelled in hard work and was a shrewd and highly successful businessman. He died under tragic circumstances on 15 November 1943 at “Blackwood Park” when a dray he was driving capsized and crushed his skull. He was survived by his widow and their 15-month-old son George and the children of his first marriage, Millicent and Trevor.<sup>7</sup> Millicent married Athol Keith Ranson, youngest son of Mr & Mrs J C Ranson, “Kia Ora”, Legerwood, on 29 November 1933. Athol died in 1963 and Millicent in 1994.<sup>8</sup>

The collection was donated to the Queen Victoria Museum and Art Gallery in 2002.
