INTRODUCTION

The collection was donated to the Queen Victoria Museum and Art Gallery in April 2011.

Prof. Henry Reynolds has donated to the QVMAG his collection of books relating to Australian Aboriginal history and politics, together with working files for some of his own publications (eg *No-Where People*; *Drawing the Global Colour Line*; *North of Capricorn*; *Law of the Land*).

Professor Reynolds is acknowledged as one of Australia's leading historians, commentators and researchers who has published extensively, particularly in the area of Aboriginal-European relations in Australia.

His work has profoundly influenced the study and debate of a wide range of topics both nationally and internationally. Subjects include frontier settlement conflict and racism, issues of sovereignty, land and associated legal issues.

"His pioneering scholarly work, especially The Other Side of the Frontier (1981), was critical in changing understandings of the Australian frontier. With The Law of the Land (1987), this prolific historian increasingly engaged with contemporary legal and political issues. In morally charged works such as This Whispering in our Hearts (1998) and Why Weren't We Told (1999), this most lucid of writers gave the cause of Reconciliation a historical underpinning." (Bain Attwood, *Companion to Tasmanian history*, 2005)

While of great significance in its own right, this donation is also seen as a natural adjunct to another QVMAG collection: Brian Plomley's book collection and archive. Reynolds' research has focussed on the conflict between the European settlement of Australia and indigenous Australians, through to modern day legal and political issues, while the strength of the Plomley Collection is its focus on early Tasmanian Aboriginal history. These two complement each other to provide QVMAG and the Tasmanian community with an outstanding resource on indigenous Australian social and cultural history and politics.

About Professor Reynolds

Born in Hobart, educated at Hobart High School and University of Tasmania. In 1965 he accepted a lectureship at James Cook University in Townsville and later became Associate Professor of History and Politics at the same University. After retiring in 1998 he took up an Australian Research Council post at the University of Tasmania in Launceston, and subsequently with the School of History and Classics and a post at Riawunna, the Centre for Aboriginal Education at the University of Tasmania.
