### **INTRODUCTION**

Cicely Colina Wymond Kelly, a prolific composer, musician and contralto singer, studied at the Melbourne University Conservatorium at an early age.

Born in London in 1911, Cicely moved to Launceston in the 1920s with her father, Wymond, originally from Tasmania, and her mother, Madame Amy, a Voice Specialist at Margaret St. Oxford Circus, London prior to the move. The family lived in a house in Ulverstone for two years before moving to their address in Elphin St, Launceston where Wymond worked as the Chief Engineer for Patons and Baldwins Woollen Mills. The family quickly became a part of the social and music scenes of the area.

She and her family moved to Launceston in the 1920s where Through musical education provided by her mother early on and a gorgeous vocal range, Cicely Kelly went on to gain a variety of musical opportunities early on in life.

Her father, Wymond, was born in Launceston and from the prominent Kelly family in Ulverstone. After living in England, where he met Amy, he moved his family back to Tasmania in 1921.

Musical education was introduced to Cicely earlier on in her life. Her mother, known as Madame Amy Kelly, was a Voice Specialist at Margaret St. Oxford Circus, London. Soon after arriving in Ulverstone the new Town Hall was officially opened, and Madam Amy Kelly was in charge of the entertainment for the event. Miss Cicely Kelly, a singer of tender years, delighted the audience with her musical abilities, including her delightful soprano voice, pianoforte solos as well duets with her mother. Not to be left out, Mr Wymond Kelly also sang.

By the age of ten, Cicely had performed in London. By the age of thirteen, Cicely had impressed Sir Bernard Heinze, then Professor with Melbourne University, while singing at Albert Hall during the Launceston Easter Competitions where he stated "her singing of 'The Lilac Tree' would do credit to an adult singer" <sup>1</sup>. Heinze encouraged Kelly's potential future in music and suggested to Madame Kelly to reduce her singing at her tender age.

The collection was donated to the Queen Victoria Museum and Art Gallery in 2014.
