INTRODUCTION

The Vineyards Association of Tasmania (VAT) was established in 1973 by wine industry operators across the state to address issues of a broader industry wide nature and to establish a point of contact with government and other relevant organisations. Claudio Alcorso, Andrew Pirie and Graham Wiltshire are considered the 'founding fathers' of the Association.

By 1994, VAT represented fifty one licensed wine producers and twenty one grape growers, producing over 98% of all Tasmanian wine. The Association strengthened the direction towards growing more suitable cool climate grape varieties as well as encouraging growers to maximise production of quality fruit.

VAT, in conjunction with the Licensing Commission and the Department of Primary Industry and Fisheries, established the Tasmanian Appellation of Origin Scheme in 1985. The scheme allowed producers of wine made from 100% Tasmanian fruit to receive additional benefits from those who produce Tasmania wine blended with fruit from other parts of Australia.

By the early 2000s, as the industry's emphasis changed from wine development to wine marketing, it became apparent that the Vineyards Association of Tasmania no longer served its original purpose, that of producing excellent Tasmanian fruit and wine that attracted top prices within Australia. In 2006, on advice from the state government that the VAT was no longer considered representative, the decision was made to wind up the Association. The Association's final newsletter was sent in January 2007, urging its members to join the new industry body, Wine Industry Tasmania.

The Vineyards Association of Tasmania's archive was donated to the Queen Victoria Museum and Art Gallery in 2018.
